

Sponsoring Agreement

Contracting parties

CYBERTEC PostgreSQL International GmbH

and

1. Sponsoring:

This Agreement specifies the terms and conditions that apply to the sponsorship of and participation in PGDay Austria 2025 ("PGDay") by the Sponsor at the following level*:

- ☐ Platinum
- ☐ Gold
- ☐ Silver

*The chosen sponsoring package will become part of the contract with the conditions according to the annex.

2. Conditions of Payment:

For the sponsoring services, which are listed in the annex and agreed upon in writing, the Sponsor pays CYBERTEC the amount of

- ☐ € 3.000,00 (Platinum)
- ☐ € 1.900,00 (Gold)
- ☐ € 900,00 (Silver)

as a sponsorship fee (excl. sales tax/VAT) and all other fees are agreed in writing. All fees are due in the next thirty (30) days from receipt of invoice without deduction. All fees are considered as fully retained by CYBERTEC and are non-refundable, unless CYBERTEC refuses the sponsoring or a part of it, in which case fees already paid will be refunded.

3. Change of Event Date or Location/Cancellation

If CYBERTEC, at its own discretion, changes the date or location of the event or cancels the event, CYBERTEC is obligated to

- (i) inform the Sponsor as early as possible about such changes or cancellations and
- (ii) in the case of event cancellation, refund any fees paid by the Sponsor.

In case of a postponement of the event, the Sponsor has to inform CYBERTEC within five days after receipt of the notification, if they cannot participate at the new date. If the Sponsor does not inform CYBERTEC within five days that it cannot participate, this agreement is considered as changed and the postponed event date is accepted as the new event date. Sponsoring fees have to be paid in full, this also applies if the event date is changed.

4. Event Guidelines

CYBERTEC may, at its own discretion, issue guidelines and rules for the proper administration of the event (in summary referred to as "guidelines"). These guidelines may be changed by CYBERTEC and will take effect as soon as the (updated) guidelines are announced to the Sponsor. The guidelines may include, but are not limited to, guidelines for the construction and placement of signs, exhibition backgrounds, use of space, approved equipment and use thereof, appropriate attire and exhibition times. If a Sponsor violates the guidelines in whole, or in part, or carries out an activity that significantly affects the rights of another event participant, the Sponsor must take immediate corrective action upon verbal or written notification from CYBERTEC. A repeated violation of the guidelines after notification of the violation, can lead to the Sponsor being banned from the event and permanently excluded from future events. No notification is required if there is a serious violation of this agreement or applicable Austrian law. CYBERTEC is not responsible for the loss of any sponsorship benefits or privileges due to negligence or intentional misconduct of the Sponsor. There will be no credit or refund for the loss of services due to non-compliance with the guidelines by the Sponsor, or for losses due to the enforcement of the guidelines. The event is a private event, which is only accessible to persons registered for the event. The Sponsor may not invite persons who are not registered as participants to the event.

5. Liability

The Sponsor is fully responsible for its personnel, employees, agents, representatives and property. They should have adequate insurance to protect against loss, theft, damage or destruction of property, and injury, including death, to its personnel, employees, agents or representatives. The insurance must cover the entire period of the Sponsor's participation in the Event. Upon request, the sponsor will provide CYBERTEC and the event center with an insurance certificate, which shows this coverage.

The Sponsor is fully responsible for its own demonstration materials and products and for insuring its property against any loss or damage. CYBERTEC is not responsible for the safety of the Sponsor, its employees or representatives and their personal property. The Sponsor shall not make any claims against CYBERTEC in case of loss, theft, damage or destruction of property or injury, including death, to itself, its employees or representatives, except in cases of gross negligence or intentional misconduct solely CYBERTEC. The Sponsor agrees to indemnify, defend, and hold CYBERTEC harmless from and against any and all third-party claims arising from its participation in the event, including but not limited to its demonstration materials and products, as well as the unauthorized use of trademarks or copyrighted material or the name or photographs of any person.

The liability of CYBERTEC towards the Sponsor, from or in connection with this agreement is limited to the total sponsoring fee, which is paid to CYBERTEC by the Sponsor within the scope of this agreement. In no event shall CYBERTEC be liable to the Sponsor for any consequential, incidental, special, or indirect damages arising out of or in connection with the event, its cancellation or any change of location, date, or otherwise, whether based on contract or tort, and whether or not CYBERTEC has been advised of the possibility of such damages. CYBERTEC makes no representations or warranties to the Sponsor, including, but not limited to, the number of participants who will attend the event or whether the event will serve as an effective marketing method for the Sponsor.

6. Sponsoring Materials

All advertising and/or presentation materials provided by the Sponsor in connection with this contract (e.g. slideshows for presentations, advertisements for conference publications) will be published in a manner and format determined by CYBERTEC. The Sponsor's materials are subject to the approval of CYBERTEC. CYBERTEC reserves the right to reproduce, promote, distribute and otherwise use these materials in connection with the event. CYBERTEC does not acquire any further rights to the materials of the Sponsor and acknowledges that it does not acquire any ownership rights to the materials of the Sponsor. The Sponsor represents and warrants that the Materials do not and will not infringe or violate any rights of any third party, including, but not limited to copyrights, patents, business secrets, trademarks, and rights of publicity or privacy, and that they are not false, misleading, deceptive, obscene, or defamatory.

7. Trademarks

CYBERTEC is entitled to use the trademarks and logos of the Sponsor in order to promote the participation of the Sponsor in the event and its sponsoring and to fulfill CYBERTEC's obligations under this agreement. CYBERTEC does not obtain any further rights to the trademarks of the Sponsor and acknowledges that it does not acquire any property rights to the trademarks of the Sponsor. The Sponsor has the right to use CYBERTEC's brands (PGDay Austria) associated with the event to promote its participation in the event. Such use must be in accordance with the corresponding guidelines of CYBERTEC for brand or company appearances. The Sponsor does not receive any further rights to the trademarks of CYBERTEC and acknowledges that it does not acquire any ownership rights to the trademarks of CYBERTEC.

8. Miscellaneous

Only the legal regulations according to Austrian law apply. For all possible disputes, the competent Austrian court at CYBERTEC's headquarters is exclusively responsible.

No information contained in any other order, pre-printed form, or document (except the attachments to this contract provided by CYBERTEC) may modify or supplement this agreement. If any term of this agreement is deemed invalid or unenforceable by a court of competent jurisdiction, then such term shall be interpreted to the maximum extent possible to reflect the intentions of the invalid or unenforceable term(s), and all other terms shall remain valid. CYBERTEC's failure to enforce any right or term in this Agreement shall not constitute a waiver of that right or term unless CYBERTEC has explicitly acknowledged and approved it in writing. This Agreement, together with the provided attachments (Sponsoring Packages), constitutes the entire agreement between the Sponsor and CYBERTEC and supersedes all prior or contemporaneous negotiations, discussions, or agreements, whether written or oral, between the parties with respect to the subject matter herein.
